Assistance with fees, discounts and funding

A 15% sibling discount on private hours and associated charges is available for the second and any subsequent child, provided each child is on a permanent booking, attending the nursery at the same time, and also accessing private hours. Please note that this discount cannot be applied on extra days.

We provide suncream for all children and formula milk for children up to 12 months old.

You may be able to reduce your nursery fees by 20% (up to £2000) using the government's Tax-Free Childcare scheme. This is a scheme that eligible parents must register for themselves and cannot be used in conjunction with Childcare Vouchers, which we also accept.

*We are pleased to offer the funded entitlement for eligible children; please note that local authority term dates decide when this funding can begin. We stretch government funding over 51 weeks, giving you an entitlement of 11.17 hours per week (taken over 2 days) if you are eligible for 15 hours or 22.35 hours per week (taken over 3 days) if you are eligible for 30 hours. Remaining fees on part-funded packages are for additional private paid hours only. These additional hours are delivered as a package and fees apply as indicated in the schedule. We do not currently charge for food, non-food consumables, or activities during funded hours, but we reserve the right make changes to our funding model at our discretion in order to ensure business viability. If you are looking to use funding only, we offer funded-only places which are part-day only. Please note, we do not currently offer FEET funding. Terms and conditions apply (available in our funded agreement).

Notes

Opening times are between 8.00am and 6.00pm Monday-Friday. The nursery closes at 3pm on Christmas Eve (standard fees still apply) and the nurseries are closed between Christmas and New Year's Day. The nursery is closed for bank and public holidays.

Fees are calculated based on the 51 weeks of the year that Christopher Robin is open, divided into 12 monthly payments. Monthly payments include bank and public holidays, which have been factored into our fee structure, and therefore no deductions will be made in months where bank and public holidays occur.

The offer of a nursery place will be accompanied by your first month's invoice and a £400 Acceptance Deposit/Advanced Payment, both of which should be paid within 14 days of the date of issue.
