## Assistance with fees, discounts and funding

\*We are pleased to offer the funded entitlement for eligible families. Funding is based on local authority term dates, which dictate when funding may begin, and is provided for 38 weeks, stretched across 51 weeks. For families eligible for the 30-hour entitlement, this equates to up to 22.35 hours per week, taken as 7.45 hours per day for up to three days (10:30am – 6:00pm). For the universal 15-hour entitlement, 11.17 hours are available per week, split across two days (7.45 hours on day one and 3.72 hours on day two, 3:15pm – 6:00pm). Hours may vary if your child attends another setting. Private fees on our part-funded package apply for any attendance beyond funded hours. The fees shown in the part-funded schedule relate to these additional hours and days, arranged as a set package rather than on an ad-hoc or hourly basis. We do not currently charge for meals, consumables, or activities during funded time, though we reserve the right to make changes to our funding model at our discretion to ensure business viability, as these costs are not funded by the government entitlement.

Funded-only places are also available for the funded hours stated above. Terms apply (see funded agreement).

A 15% sibling discount on private hours and associated charges is available for the second and any subsequent child, provided each child is on a permanent booking, attending the nursery at the same time, and also accessing private hours. Please note that this discount cannot be applied on extra days.

We provide suncream for all children and formula milk for children up to 12 months old.

You may be able to reduce your nursery fees by 20% (up to £2000) using the government's Tax-Free Childcare scheme. This is a scheme that eligible parents must register for themselves and cannot be used in conjunction with Childcare Vouchers, which we also accept.

### **Notes**

Opening times are between 8.00am and 6.00pm Monday-Friday. The nursery closes at 3pm on Christmas Eve (standard fees still apply) and the nurseries are closed between Christmas and New Year's Day. The nursery is closed for bank and public holidays.

Fees are calculated based on the 51 weeks of the year that Christopher Robin is open, divided into 12 monthly payments. Monthly payments include bank and public holidays, which have been factored into our fee structure, and therefore no deductions will be made in months where bank and public holidays occur.

Where applicable, the offer of a nursery place will include your first month's invoice and an Acceptance Deposit/Advanced Payment request of £400. This deposit will be applied toward private fee payments. Both should be paid within 14 days of the date of issue.
